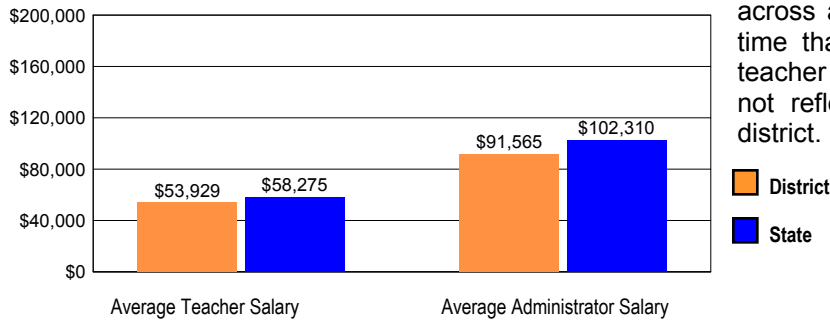

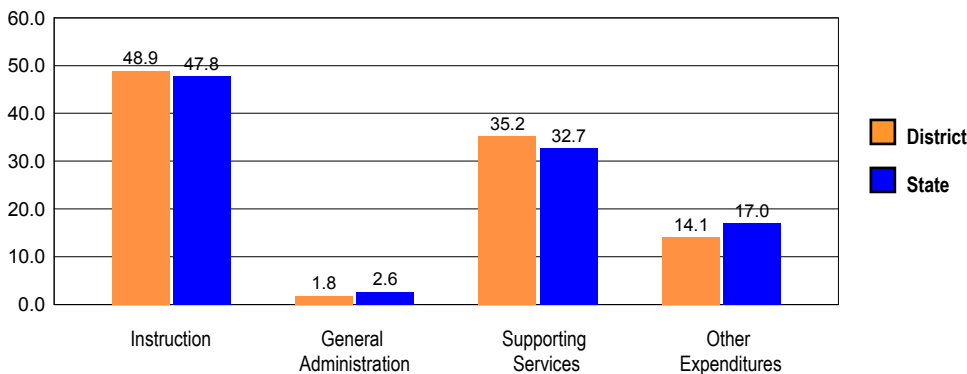
## SCHOOL DISTRICT FINANCES

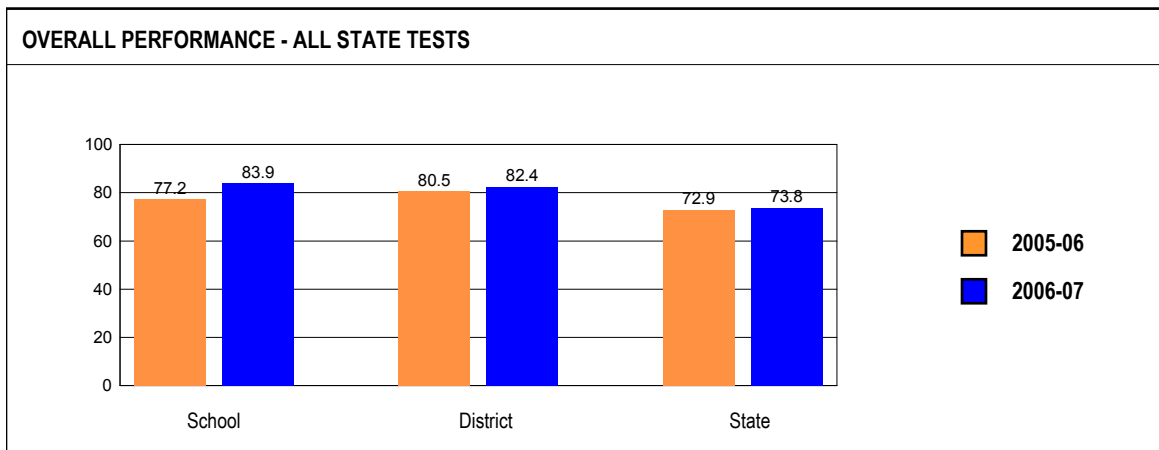

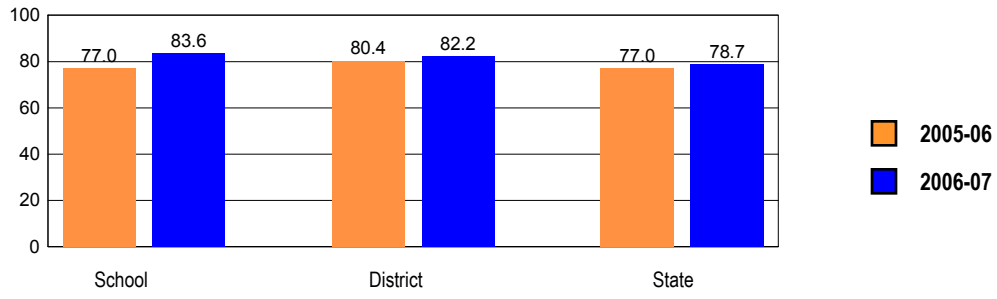

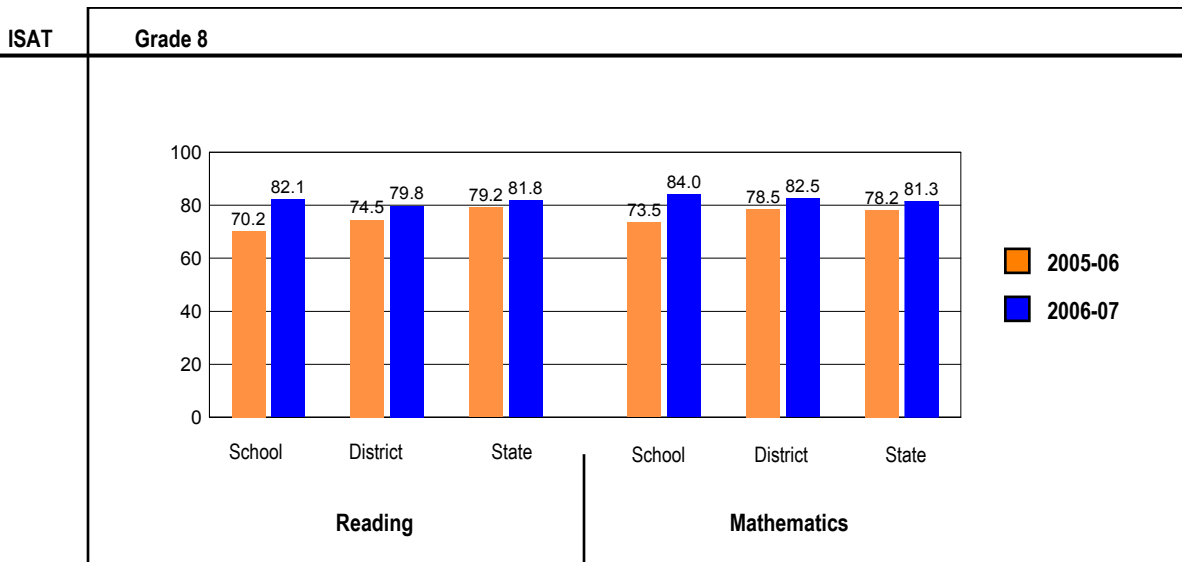
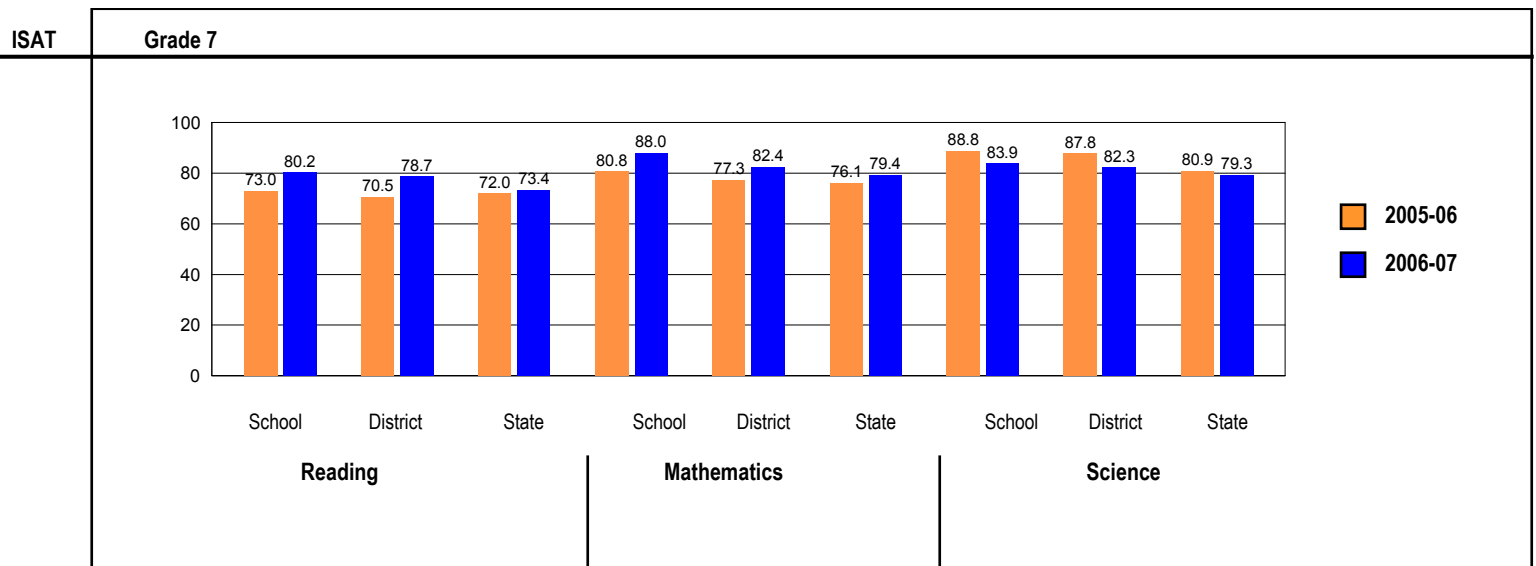


**OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE**

## PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Measure of Annual Growth in English (IMAGE) is administered to limited-English-proficient students. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

### ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

- Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.
- Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.
- Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.
- Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

Broadmoor Junior High School participates in an annual school-wide improvement planning process (SWIP). The SWIP process requires the use of data as the basis of discovering targeted goals for improvement. The data sources used to inform Broadmoor Junior High School's Improvement Plan include:

- 1) 2007 Illinois Standards Achievement Test;
- 2) Spring 2007 Ed Performance Data and;
- 3) Fall 2007 Ed Performance Data.

The annual SWIP process incorporates processes and tools that involve the entire building in selecting research-based strategies to address improvement goals. The following goal(s) were selected for this school year:

- 1) Math – If students increase their knowledge of the math facts, in addition to focus on algebra concepts, then student achievement on ISAT will increase;
- 2) Literacy – If we use the National Geographic Non-Fiction Reading and Writing workshop, then student achievement on ISAT will increase;
- 3) Writing – If language arts teachers' study current best practices in writing, then the understanding of the writing process by the language arts teachers will improve.
