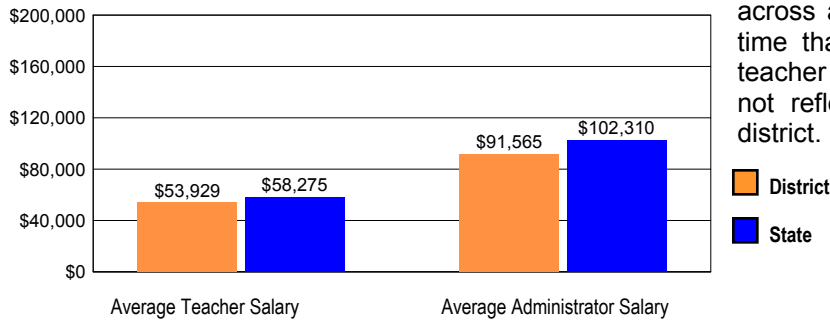

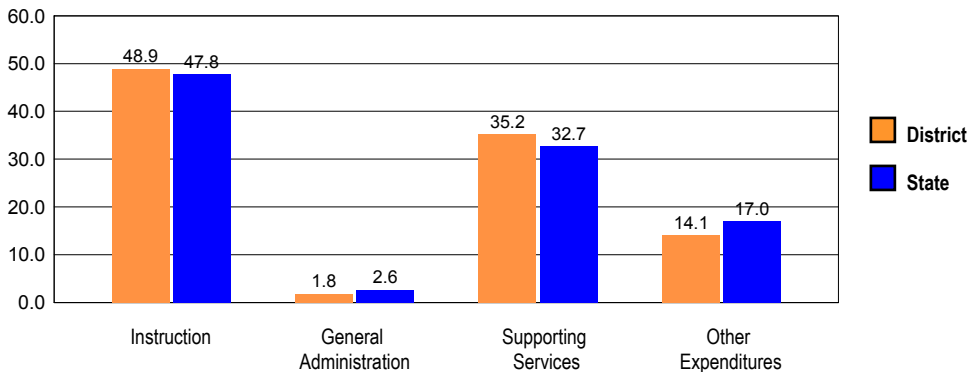
SCHOOL DISTRICT FINANCES

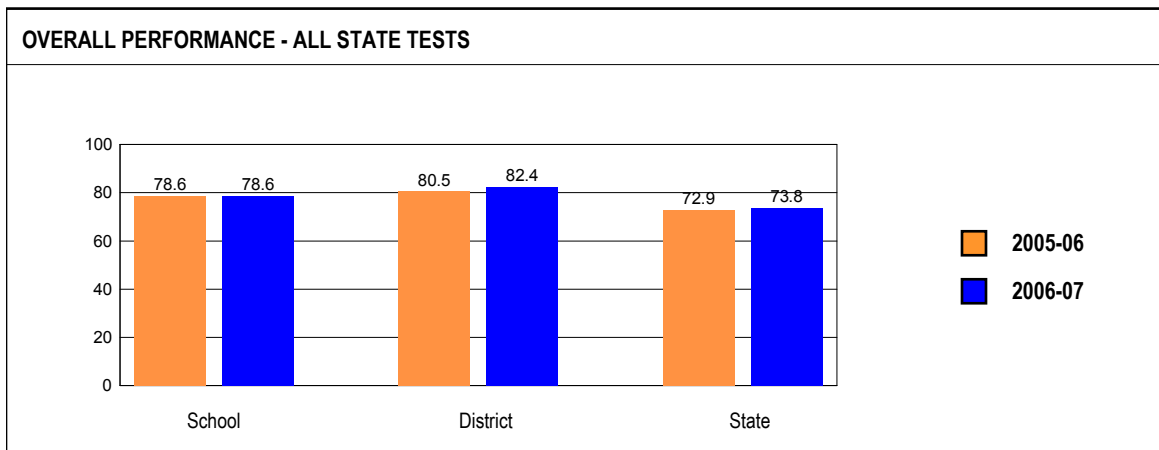

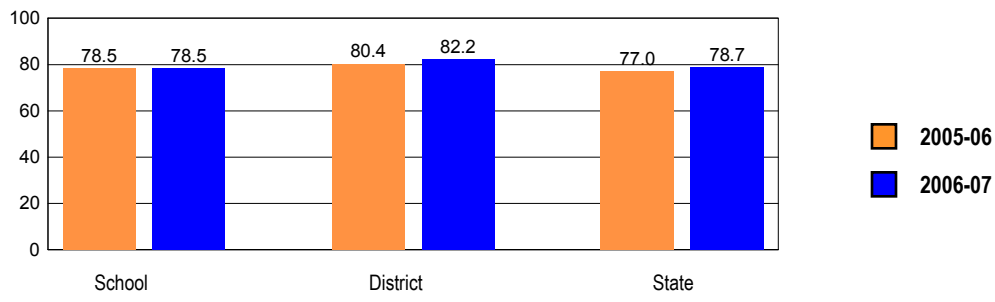

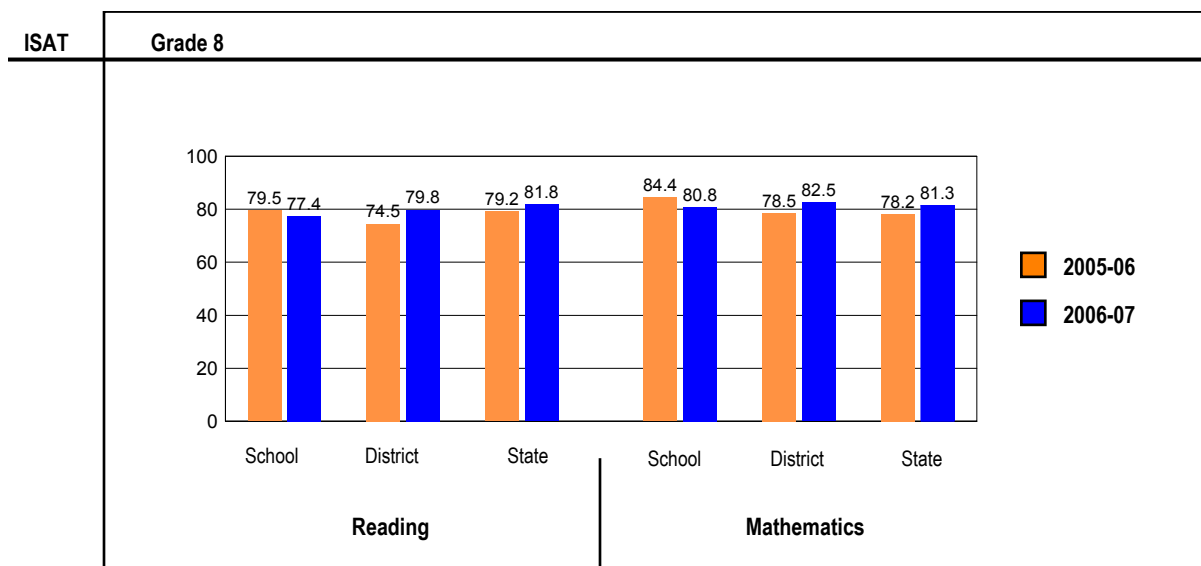
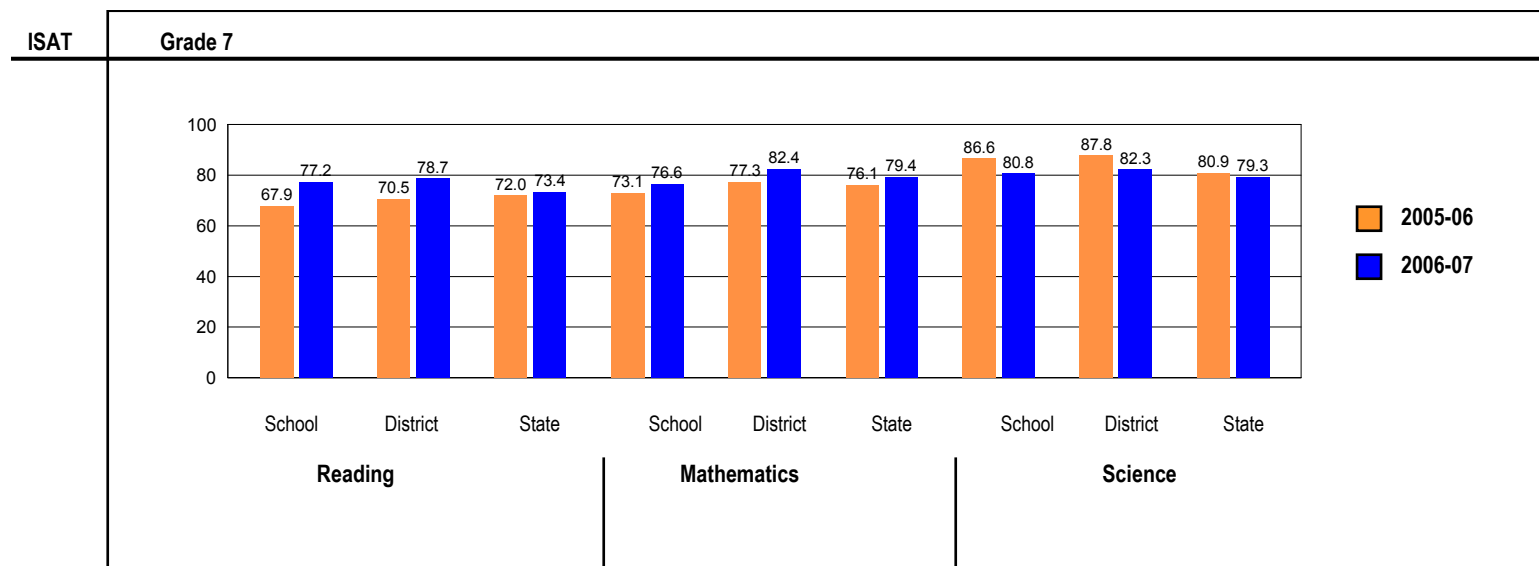


OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE



ISAT PERFORMANCE

These charts provide information on attainment of the Illinois Learning Standards. They show the percents of student scores meeting or exceeding Standards for the grades and subjects tested on ISAT.

**PERFORMANCE ON STATE ASSESSMENTS**

Federal law requires that student achievement results for reading, mathematics and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Measure of Annual Growth in English (IMAGE) is administered to limited-English-proficient students. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

- Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.
- Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.
- Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.
- Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

Edison Junior High School participates in an annual school-wide improvement planning process (SWIP). The SWIP process requires the use of data as the basis of discovering targeted goals for improvement. The data sources used to inform Edison Junior High School's Improvement Plan include:

- 1) ISAT Test results;
- 2) Ed Performance Fall Assessment results and;
- 3) Ed Performance Spring Assessment results.

The annual SWIP process incorporates processes and tools that involve the entire building in selecting research-based strategies to address improvement goals. The analysis conducted during the SWIP process demonstrated a need to focus the efforts of the school on the following content areas: science, math, reading and social studies. In addition, the subgroups of special education in the areas of math and reading are targeted in the school improvement process. The following goal(s) were selected for this school year:

- 1) Special Education - To improve student performance on the ISAT math and reading test by implementing a standardized process to deliver researched based interventions;
- 2) Science & Social Studies - To improve student performance on the ISAT reading test in the area of Non-Fiction Comprehension;
- 3) Math - To improve student performance on the ISAT math test in the areas of Algebra and Problem-solving;
- 4) Language Art - To improve student performance on the ISAT writing test by developing a data baseline for research based writing strategies;
- 5) Social Emotional Learning -To research and implement a social-emotional program that compliments the school's code of conduct.
